### 2022 Legislative Session

### **Final Report**

**BE BOLD.** Shape the Future. **New Mexico State University**  The legislature met for thirty days and completed action on bills on February 17, 2022, at noon. During a thirty-day session only fiscal-related matters are germane unless the Governor provides a message on a bill that is not fiscal-related. The Governor had until March 9, 2022, to sign, veto, or line-item veto bills. All bills that are not acted upon by March 9, 2022, are pocket vetoed.

This year was an unprecedented year in terms of overall funding revenues. The December 2021 Consensus Revenue Estimate included a total \$1.599 billion in new money for FY23. The report also estimated ending balances of \$3.3 billion or 43.9% percent of recurring revenues for FY22.

The legislature passed and the Governor acted upon four funding bills:

- HB2 General Appropriation Act of 2022 (Partial Veto, Ch. 57, Laws 2022)
- <u>SB48 General Appropriations and Authorizing Expenditures (otherwise known as HB2 Junior- Veto)</u>
- HB 153 General Obligation Bond Projects (Partial Veto, Ch. 55, Laws 2022)
- <u>SB 212 Capital Outlay Projects (STB Bill Partial Veto Ch. 53, Laws 2022 )</u>

The legislature passed and the Governor acted upon an additional 9 bills that were directly or indirectly related to higher education. Of these, the major bills include:

- <u>HB 39 GRT Deduction for Non-Athletic Special Events (NMSU requested bill Ch. 50, Laws</u> 2022)
- HB 73 Educational Retirees Returning to Work (Ch. 20, Laws 2022)
- <u>SB36 Contributions to the Educational Retirement Fund (Ch. 29, Laws 2022)</u>
- <u>SB140 Opportunity Scholarship Act (Ch. 42, Laws 2022)</u>

#### Major Higher Education/NMSU Highlights

- Enactment of SB140 Opportunity Scholarship
- Enactment of HB39 GRT Deduction for Non-Athletic Special Events
- \$77.7 million in new operating and Capital Outlay for the NMSU System after the Governor's vetoes (\$56.6 million in capital outlay \$21.1 million in recurring/nonrecurring operating)
  - The Governor vetoed a total of \$6.4 million in funding destined for the NMSU system (\$430,000 for one capital outlay project included in SB 212 (STB) and \$6.0 million in projects contained in SB 48 (the Junior Bill))
- \$230.5 million for financial aid in both appropriations bills and transfers to financial aid related funds including a \$130 million transfer to the lottery tuition fund and \$75 million for the Opportunity Scholarship (of which \$12 million is recurring)
- \$45 million for research matching funds
- \$137 million for endowed faculty and other positions
- \$15 million for expanding enrollment in nursing programs
- A 7% compensation increase with a 3% down payment in the last quarter of FY22
- Funding for a \$15.00 minimum wage (applied after the 7% compensation increase)

#### Summary of Governor's Veto/Line-Item Vetoes of General Appropriation and Capital Outlay Bills Impacting Higher Education and/or NMSU

HB2 General Appropriation – Partial Veto (See pages 15-18 for details)

• Veto of Section 8.C. for \$4,230,100 for the Department of Finance and Administration to increase medical insurance premiums paid by employers on behalf of state employees covered by health plans managed by the General Services Department by 5 percent. Section 8.C. would have impacted the NMSU system by approximately \$840,000 if not vetoed.

SB48 General Appropriations and Authorizations - Veto (See pages 35-38 for a listing of projects)

- The Governor vetoed the entire bill
- Included \$50.4 million in recurring/non-recurring funding (\$25.2 million recurring, \$25.2 million non-Recurring)
- The bill included a total of \$6.0 million for 52 projects that impacted the NMSU System

SB212 STB Capital Outlay Projects – Partial Veto (See pages 40-43)

- The Governor vetoed \$4,624,900 for various projects in the bill
- The vetoes include \$430,000 for the NMSU Fabian Garcia Agricultural Science Center

#### HB2 Highlights – All Higher Education

The passed bill includes a total of \$939.1 million in operating funding for higher education institutions, special schools and the Higher Education Department, an increase of \$44.2 million or 4.9% over the FY22 operating budget (See appendix for specific details). The Governor did not veto any funding in HB2 that impacts NMSU or higher education, but she did veto some language deemed as enacting policy. Of note:

- An increase of \$21.6 million (3.4% above FY22) in recurring Instruction and General funding for all higher education institutions
- \$12 million recurring for the Opportunity scholarship, \$5.0 million above FY22
- An increase of \$8.9 million (an 8.2% increase) for other categorical and RPSP items
- The passed bill includes funding for a 3% **compensation increase** for the last quarter of FY22 and a 4% increase in FY23 for non-student employees
- Also included is funding to bring all higher education employees (excluding student employees) to a minimum wage of \$15/hour after the compensation increases have been implemented

The passed bill includes non-recurring appropriations of \$349.8 million for various projects within higher education including:

- \$63 million for the opportunity scholarship (a total of \$75 million counting recurring funding)
- \$20 million for research matching funds (including \$25 million transferred to the research technology fund)
- \$137 million for endowed faculty positions including:
  - \$50 million for educator preparation programs
  - \$30 million for nursing programs
  - \$50 million for bachelor and master's degree social worker programs
  - \$7 million for early childhood positions

- \$4.0 million for dual credit
- \$5.0 million the higher education endowment fund
- \$15.0 million for expanding enrollment and graduation in nursing programs
- \$8.0 million for building renewal and replacement
- \$20 million for work study students in high-demand degree fields
- \$15 million for schools of public health (\$10 million for UNM and \$5 million for NMSU)
- \$1.7 million for cyber security
- \$3.5 for demolition of buildings at higher education institutions

#### **NMSU-Specific Funding Highlights**

NMSU receives a total of \$292.5 million, after the Governor's \$6.4 million veto, in the general appropriation and capital outlay bills. This is a total \$77.2 million in new funding (and excludes funding for compensation, ERB and a \$15 minimum wage). HB2 includes \$227.8 million in recurring funding to NMSU. This represents a \$7.9 million increase (3.7%) to the institution. There is an additional \$13.2 million in new, nonrecurring funding (see pages 22-33 for details) in the budget bill, while capital outlay projects across the NMSU system receive another \$56.6 million in funding (see pages 40-43for details). By vetoing SB 48 in its entirety, the Governor blocked \$6.0 million in additional recurring and nonrecurring funding for NMSU (See pages 35-38 for details).

#### NMSU HB2 – General Appropriations Act

For FY 23, HB2 includes \$165.5 million in recurring funding for I&G across the higher ed system, an increase of \$4.5 million (or 2.8%), while Non-Instruction and General (including athletics, educational television, New Mexico Department of Agriculture and Research and Public Service Projects) receives \$57.2 million, an increase of \$3.4 million (6.3%). The table below shows the details of the recurring funding included in HB2.

#### NMSU SYSTEM CAPITAL OUTLAY

The legislature approved two capital outlay bills: House Taxation and Revenue Committee Substitute for HB153, (HTRC CS/ HB153) containing general obligation bond (GOB) projects, and the Senate Finance Committee Substitute for SB212 (SFC CS/ SB212) that includes Severance Tax Bond projects (STB).

The GOB bill authorizes the issuance of general obligation bonds totaling \$215.6 million for higher education, special schools, and tribal school capital improvements and acquisitions. The bill includes the authorization of \$51.1 million for the NMSU system, broken down by project in the following table. The authorized issuance of the bonds will go before voters in November statewide elections and will be question C.

The STB bill authorizes the issuance of severance tax bonds totaling \$36.9 million for higher education institutions. NMSU received a total of \$5.5 million, after the Governor's veto of \$430,000, for various projects for New Mexico Department of Agriculture, the Agricultural Experiment Station, Athletics, ASNMSU, Auxiliary Services, and KRWG.

In all, \$56.6 million was authorized for the NMSU System after the Governor's veto (see pages 40-43).
