HIGHLIGHTS

Chaptered Bills

On April 9, 2021, the Governor acted on all funding bills with line-item vetoes. The legislature had approved a total of \$18.8 million in operating (recurring/nonrecurring) and capital outlay funding in three separate funding bills described below for the NMSU system. With the Governor's actions the NMSU system ended with a total of \$16.0 million. The Governor vetoed \$250,000 for two projects in SB377-Chapter 140 (General Appropriations and Expenditures) and \$2.6 million for four projects in HB285 – Chapter 138 (Capital Outlay Projects). No funding projects were vetoed for the NMSU system in HB2 (General Appropriations Act).

The line-item-vetoed items are depicted with a strikethrough in the following attachments.

HB2 (Chapter 137) – General Appropriations Bill for FY22 (Pg. 2-8)

- The House and Senate action to date restores the \$4.7 million I&G Federal SWAP reduction for the NMSU system that was taken during the special session (\$20 million restoration higher education I&G)
- The I&G funding formula includes 0.5% new money (\$3.1 million), two percent redistribution and a hold harmless provision for institutions with negative funding.
- 208,362.3 million in recurring funding for FY22, an increase of \$5.4 million or 2.7 percent compared to the FY21 Special Session (see attached table)
- \$862,500 in non-recurring funds for New Mexico Department of Agriculture and the Agricultural Experiment Station
- Over \$33 million in State financial aid including funding for the lottery and opportunity scholarships ~~including \$100 million place holder for lottery scholarships from the Corona Virus State Fiscal Recovery Fund included in the 2021 American Rescue Plan Act~~
- 1.5% ~~average~~ compensation increase for higher education (Governor vetoed the word “average” meaning an across the board increase for all employees)
- \$34.0 million for the 1% ERB employer contribution that is included in SB42 for both higher and public education
- \$5.0 million in non-recurring funds for the Higher Education Endowment Fund that provides a two to one match for purposes stated in Section 21-1-27.1 NMSA and \$2.0 million for endowed early childhood positions

SB 377 (Chapter 140) - General Appropriations and Expenditures (HB2 Junior) (Pg. 9-13)

- \$2.2 million in recurring and non-recurring funding for various projects for the NMSU system after the Governor's line-item-veto of \$250,000 for two projects related to studies

HB 285(Chapter 138) - Capital Outlay (Pg. 14-17)

- \$7.5 million for the NMSU system projects after the Governor's line-item-veto of \$2.6 million for four projects (excludes funding for Soil and Water Conservation Districts)

HB2 GENERAL APPROPRIATIONS FOR FY22

The Governor signed HB2 on April 9, 2021 with line-item-vetoes. None of the funding items specifically related to NMSU was line-item-vetoed, however the Governor did line-item-veto the \$100 million transfer to the Lottery Scholarship fund, some language associated with the Opportunity Scholarship, the word “average” associated with the compensation increase and the contingency language associated with group health insurance (Section 5 item 35), and other minor language as illustrated below (line-item-vetoed language/funding includes a strikethrough).

HIGHLIGHTS - PASSED BILL

- The passed bill restores the \$4.7 million I&G Federal SWAP credit for the NMSU system that was taken during the special session (\$20 million for all higher education institutions).
- Adds 0.5% (\$3.1 million) in new money for the higher education funding formula for all institutions.
- The NMSU system is funded at \$208,362.3 (recurring) for FY22, an increase of \$5.4 million or 2.7% when compared to the FY21 special session (see attached table).
- State Financial Aid
 - Opportunity Scholarship – Includes a total of \$18.0 million for the opportunity scholarship (\$7.0 million recurring and \$11.0 million non-recurring).
 - Lottery Scholarship – Includes a \$15.5 million in non-recurring funding ~~and a transfer of \$100 million transfer from the coronavirus state fiscal recovery fund that was enacted in 2021.~~
 - Other forms of financial aid include: \$15.0 million for the College Affordability Scholarship Fund and \$500,000 for the Grow Your Own Teachers Fund.
- 1.5% ~~average~~ compensation increase for higher education.
- Includes \$34.0 million for the 1% ERB employer contribution that is included in SB42.
- Includes \$5.0 million in non-recurring funds for the Higher Education Endowment Fund that provides a two to one match for purposes stated in Section 21-1-27.1 NMSA.

SECTION 4 J HIGHER EDUCATION (Recurring) – FISCAL YEAR 2022 APPROPRIATIONS

- Restores the \$20.0 Federal Funds SWAP for I&G that was enacted during the 2020 1st special session. This is a restoration of \$4.7 million for the NMSU system.
- I&G funding formula (all institutions) - Adds 0.5% (\$3,072,753) new money; 2% redistribution and holds harmless from any formula reductions by sanding those institutions who had positive funding; modified the performance distribution percentages for MP30, MP60 and Dual Credit.

- The NMSU system is funded at \$208,362.3 (recurring) for FY22, an increase of \$5.4 million or 2.7% when compared to the FY21 special session (see table page 7).
 - NMSU System Instruction and General increased by \$5.2 million or 3.5% above the FY21 Special Session operating levels.
 - Non-Instruction and General programs increased by \$196,400 or 0.4% when compared to FY21 special session.
 - Includes flat budget for NMDA, AES and CES compared to the proposed cuts proposed by the Executive and the Legislative Finance Committee, reduction of \$887,300 and 597,400 respectively.
 - Includes a flat budget for Nursing Expansion programs when compared to the FY21 special session Research and Public Service are decreased by 2.1 percent or \$161,100 below the FY21 Special Session level and \$1.6 million above the FY20 level.
 - The athletics budget was increased from a proposed reduction of \$111,400 in the recommendations to an increase of \$388,600 or 10.5% when compared to the FY21 special session level.

LANGUAGE

- On approval of the higher education department ~~and in consultation with the legislative finance committee~~, the state budget division of the department of finance and administration may reduce general fund appropriations, up to three percent, to institutions whose lower level common courses are not completely transferrable or accepted among public colleges and universities in New Mexico.

- The secretary of higher education shall work with institutions, whose enrollment has declined by more than fifty percent within the past five academic years, on a plan to improve enrollment, collaborate or merge with other institutions, and reduce expenditures accordingly and submit an annual report ~~to the legislative finance committee.~~

HED BUDGET

- Teacher Preparation and College Affordability - The other state funds appropriation to the student financial aid program of the higher education department includes five million dollars (\$5,000,000) from the teacher preparation affordability scholarship fund and two million dollars (\$2,000,000) from the teacher loan repayment fund.
- Opportunity Scholarship – Includes \$7.0 million from the general fund with the following language:

The general fund appropriation to the opportunity scholarship program of the higher education department in the other category includes seven million dollars (\$7,000,000) for an opportunity scholarship program in fiscal year 2022 for students attending a public postsecondary educational institution or tribal college. The scholarship may be used by eligible students to pay tuition or ~~general student fees and shall not be used to pay differential tuition or individual course-specific fees.~~ The opportunity scholarship program shall prioritize financial aid based on need to undergraduate, degree-seeking students ~~who have left higher education but have earned seventy five percent of credits toward an associates or bachelor's degree,~~ who have completed the free application for financial student aid or another form of income verification, who are adults or eligible for a lottery tuition scholarship and who are enrolled full-time. The higher education department shall provide a written report summarizing the opportunity scholarship's finances, student participation and sustainability to the department of finance and administration ~~and the legislative finance committee by November 1, 2021. Any unexpended balances remaining at the end of fiscal year 2022 from appropriations made from the general fund shall revert to the general fund.~~

SECTION 5 – SPECIAL APPROPRIATIONS

(35) GENERAL SERVICES DEPARTMENT - \$7.6 million for a projected shortfall in the employee group health benefits fund ~~contingent on implementing a plan to raise matching funds from local governments and higher education institutions of three million three hundred thousand dollars (\$3,300,000) and on the general services department increasing health benefit premiums in fiscal year 2022.~~ *(Note: this could possibly cost NMSU system between \$800,000 to \$1.0 million).*

(63) EARLY CHILDHOOD EDUCATION AND CARE DEPARTMENT - \$2.0 million for endowed early childhood positions, including those necessary for increasing the number of indigenous and bilingual early childhood educators, at New Mexico public and tribal institutions of higher education contingent on matching funds from the higher education institution through fiscal year 2023. The other state funds appropriation is from the early childhood education and care department's private pre-k account. Any

unexpended balances remaining at the end of fiscal year 2023 from this appropriation shall revert to the early childhood education and care fund.

(111) HIGHER EDUCATION DEPARTMENT - \$500,000 for scholarships for the grow your own teacher program. The other state funds appropriation is from the public education reform fund.

(112) HIGHER EDUCATION DEPARTMENT - \$11.0 million for the opportunity scholarship program.

(113) HIGHER EDUCATION DEPARTMENT - \$100,000 to purchase national student clearinghouse data related to high school to college articulation. The other state funds appropriation is from the public education reform fund.

(114) HIGHER EDUCATION DEPARTMENT - \$1.0 million to support mental health services for students in higher education institutions. The other state funds appropriation is from the consumer settlement fund at the office of the attorney general.

(115) HIGHER EDUCATION DEPARTMENT - \$10.5 million to the lottery tuition fund.

(116) HIGHER EDUCATION DEPARTMENT - \$5.0 million to the lottery tuition fund. The other state funds appropriation is from the consumer settlement fund at the office of the attorney general.

(117) NEW MEXICO STATE UNIVERSITY - \$500,000 For the agricultural experiment station for weather stations. The other state funds appropriation is from the mortgage regulatory fund.

(118) NEW MEXICO STATE UNIVERSITY - \$212,500 for the New Mexico department of agriculture to develop and administer a weather modification program.

(119) NEW MEXICO STATE UNIVERSITY - \$150,000 for the New Mexico department of agriculture to support the development of a local meatpacking cooperative.

SECTION 7 – INFORMATION TECHNOLOGY APPROPRIATIONS

(39) HIGHER EDUCATION DEPARTMENT - \$401,000 for a commercial off-the-shelf longitudinal data system. The appropriation includes two hundred one thousand dollars (\$201,000) from the public education reform fund.

(40) HIGHER EDUCATION DEPARTMENT - \$3,125,000 For a shared services enterprise resource planning system. The appropriation includes two hundred fifty thousand dollars (\$250,000) for a predictive analytics software system to report statewide performance metrics.

SECTION 8 – COMPENSATION APPROPRIATIONS

A. (6) twelve million four hundred twenty-one thousand two hundred dollars (\$12,421,200)

to the higher education department to provide faculty and staff of two-year and four-year public postsecondary educational institutions, New Mexico military institute, New Mexico school for the blind and visually impaired and New Mexico school for the deaf with an ~~average salary~~ increase of one and one-half percent.

D. Thirty-four million dollars (\$34,000,000) is appropriated from the general fund to the department of finance and administration to provide incumbents in positions covered by a pension plan created under the Educational Retirement Act a one percent employer-paid pension contribution increase contingent on enactment of Senate Bill 42 or similar legislation in the first session of the fifty-fifth legislature increasing employer-paid pension contributions. Any unexpended balances remaining at the end of fiscal year 2022 shall revert to the general fund.

(7) TEACHER PREPARATION AFFORDABILITY SCHOLARSHIP FUND - \$20.0 million

(8) TEACHER LOAN REPAYMENT FUND - \$5.0 million

~~(13) LOTTERY TUITION FUND — \$100 million from the appropriation contingency fund of the general fund contingent on the transfer of federal coronavirus state fiscal recovery fund revenue authorized in the American Rescue Plan Act of 2021 into the appropriation contingency fund of the general fund.~~

(14) HIGHER EDUCATION ENDOWMENT FUND - \$5.0 million the higher education department shall require a fifty percent match of any awards from recipient institutions of higher education.

SB377 General Appropriations and Expenditures

The Senate Finance Committee substitute for SB 377, as amended by the House Appropriations Committee, passed the legislature on March 18, 2021 and signed by the Governor on April 9, 2021. This bill is commonly referred to as HB2 Junior. The bill as passed by the legislature included a total of \$2,375,200 specifically for New Mexico State University System and an additional \$425,000 in other state agencies that also relate to New Mexico State University. The Governor line-item-vetoed two projects totaling \$250,000 for programs related to studies leaving a total of \$2,200,200. All of the vetoes in the bill had language associated with studies. See attached tables on pages 10-14 for a summary of the items included in SB377 and bill language.

The final chaptered bill includes \$1,117,600 in recurring funds and \$1,082,600 in non-recurring funds for the NMSU System. The Department of Finance and Administration will make the final determination how the funds are scored as recurring or non-recurring. The non-recurring funds are available in FY21 and FY22 while the recurring funds are available for FY22. All unexpended funds revert to the general fund (Governor vetoed "or unencumbered" language throughout the bill).

The legislatively passed bill includes \$425,000 for other state agencies that also impact New Mexico State University as shown on the attached table. The Governor vetoed \$100,000 for the Tax & Revenue Department Military Retirement Pay Study.

- The \$100,000 in funding within the Energy, Minerals, and Natural Resources (EMNRD) is contingent to the passage of HB262 (Energy Storage System Tax Credit) which did not pass. NMSU would have created the app to track the storage system income tax credit that is included in the bill.
- ~~Includes \$100,000 to the Taxation and Revenue Department to study the effects of eliminating the state income tax on military retirement pay and is also associated with HB295 (Study Effects of No Tax on Military Retirement) which requests the Agriculture Economics Department to complete the study.~~
- \$275,000 is appropriated to the Human Services Department to develop and implement a comprehensive plan to address hunger and food insecurity and strengthen food systems in the state in partnership with other agencies and stakeholders. NM Department of Agriculture is a participant.

The table on page 10 shows the combined impact of the projects included in SB377 and HB2. HB2 and SB377 includes \$8,489,700 in new recurring and new non-recurring funding.

The legislatively passed capital outlay bill included a total of \$10,075,500 for NMSU System specific projects and \$685,000 for Soil and Water Conservation related projects for a total of \$10,760,500. It included \$8,237,500 for statewide projects and \$1,838,000 for projects provided by individual legislators for the NMSU system. The signed chaptered bill includes a total of \$7,464,500 a decrease of \$2,611,000 for four vetoed projects for the NMSU system:
